What we do

More and more volumes of data are published every day. A substantial amount of this data is collected by governments. But for the data to be used, it needs to be accessible.

The launch of the European Data Portal is one of the key steps the European Commission is taking to support the access to public data. The Portal harvests the metadata of the Public Data made available on national data and geospatial portals in European countries. Beyond making data accessible, the Portal addresses the whole data value chain: from data publishing to data re-use.

A series of support activities are designed to foster the publishing of more data. In addition, the re-use of public data is encouraged, as this will

drive economic benefits and innovation.

Training and Library

To support data publication re-use, the European Data Portal hosts a Training and Library section.

The Library offers a central access point to material on and around Open Data. Material from many European funded projects is made available. Also, all Open Data news items posted on the Portal are archived here.

The Training section is an interactive online learning environment. Training has proven a vital step in providing the necessary support to increase the release of data sets.

The eLearning programme on Open Data is designed to be as more practical as possible, so that trainees not

only gain knowledge about the most up-to-date techniques and best practices but also learn how to best apply that knowledge in their daily activities.

The offered eLearning modules differ in depth of content. The first modules focus on general questions. Further modules deal with advanced technical details. The learning section is divided as follows:

What is Open Data?

Essential questions are answered: What is data? What makes data open?

Unlocking value from Open Data

How do governments, businesses and individuals use Open Data to create new value?

Open Data. Agent of Change

Understanding similar characteristics of successful initiatives can help unlocking value of Open Data.
